Dear Brothers in Christ:

I write to you at the request of the Roman Catholic Ad Hoc Committee (the "Committee") to ask that if you or one of your organizations is a sponsor of scouting activities (a "Chartered Organization), that it refrain from voting on the plan of reorganization ("Plan") proposed by the Boy Scouts of America ("BSA"). As a Diocese, we have been monitoring the development of this plan, especially given our situation of also being involved in a reorganization process. The Committee is analyzing the Plan and attempting to improve its treatment of Catholic Chartered Organizations. Coordinating the vote of Catholic Chartered Organizations will be very important to achieve this objective.

The Committee. The Committee was formed by several Catholic archdioceses and dioceses¹ and Catholic Mutual Relief Society of America in connection with the BSA bankruptcy. The Committee's purpose is to advocate for the interests of the Roman Catholic Church in connection with BSA's bankruptcy.

The BSA Bankruptcy Plan. BSA filed for bankruptcy in the wake of many sexual abuse claims asserted by former and current scouts. Some of these claims also name Boy Scout Local Councils and Chartered Organizations that sponsor scouts as defendants or potential defendants. If BSA is able to successfully emerge from bankruptcy, it will receive immunity from sexual abuse claims filed before the bankruptcy. As things stand today, however, Chartered Organizations will not receive the same protection. Accordingly, what is at stake for Chartered Organizations in the BSA bankruptcy is potential significant financial burden from the same sexual abuse litigation that drove BSA into bankruptcy.

Ongoing Negotiations and Future Voting Recommendation. The Committee is attempting to remedy those issues and are currently evaluating their options which may ultimately conclude with a recommendation to object to the Plan. In any event, it will make a recommendation regarding the Plan after its November 22, 2021 meeting.

Chartered Organizations Should Not Vote Yet or Exercise any "Opt Out" Form Yet. One of your parish or school organizations may have received copies of the Plan, which is BSA's proposal to emerge from bankruptcy and shed its sexual abuse liabilities. Along with the Plan, they may also have received the accompanying disclosure statement, a summary of Chartered

Organizations' options under the Plan with an "opt out" attachment, and the ballot form. They should review these documents carefully, but they are extremely complex. The Committee suggests that voting should await the Committee's recommendation, including a sample ballot and explanation.
